Thank you for your interest in participating in the Yolo County Early Juneteenth Celebration on Sunday, June 2, 2024, from 10 a.m. to 5 p.m. This year's celebration will be taking place at the UC Davis Activities & Recreation Center, located at 760 Orchard Road, Davis, CA 95616.

Deadline for vendors is **May 10, 2024**. All vendors must be approved to participate. Anyone interested in vending should turn in this application as soon as possible. **Please do not pay until asked to.** We must ensure that there is a good distribution of vendor types, so vendors will be screened. Vendor types will be considered first come first serve. Once approved, you will be notified of how to pay your vending fee (online or by mail). Your participation is not guaranteed until your payment have been received. If payment is not received within 7 days of approval, you may lose out on your space.

Each space is \$60, and we will include your website or contact information on the Juneteenth website marketplace until January 1, 2025.

- Vendors will be supplied 8' x 30" table space and two chairs, depth of space may vary, table may be touching the next vendor's tables, meaning you may not have space on the side to display. Vendors wanting more space can pay for multiple spaces, if approved.
- Set up of your space can begin at 8:30 am and **MUST BE** completed by 9:45 am. Vendor is responsible for setup, breakdown, and clean-up of their table. Breakdown is not allowed until 5 p.m.
- Vendor is responsible for everything related to their table. **No refunds**
- Vendor, or their agent, shall not injure, deface, or modify any part of the site property and agrees to hold harmless Yolo County Library, UC Davis or its' agents responsible for any injury or loss of any kind.
- **If applicable, sellers must have a Sellers Permit, or Temporary Sellers Permit from the State of California. More information can be found at cdtfa.ca.gov**
